The Borough of Litchfield Historic District Commission held **Public Hearings** on **Thursday, April 16, 2026** at the Pilgrim House, First Congregational Church, 21 Torrington Road, Litchfield, Connecticut. The hearings were called to order by Acting Chairman, Norman Ambrose Sauer at 7:00 pm.

Present were Commissioners: Glenn Hillman, Norman Ambrose Sauer, Julia Metcalf, Tony Cecchinato and Bob Whelan (Alt).

Commissioners Absent: Wendy Simoncelli and Jarett Monterio (Alt).

Also present were: Jeff Russak, Steven Byrne, Nicole Byrne, Jock and Lee Lawrason, Michael Rybak, Ken Merz, Paul Frank, Michael and Lisa Archibald, Pat and Michael Brady and Chris Verrilli.

At 7:01 pm, Ms. Metcalf made a motion to seat Mr. Whelan as a regular Commissioner for this meeting. Mr. Hillman seconded. Motion carried.

Mr. Hillman, Clerk, read the legal advertisement of each hearing as published. The Chair explained the procedure for conduct of the hearings and described each application.

The public hearing published April 10, 2026 in the Republican American, Application #2649, William Lienhard and Launa Schweizer, 44 South St, to install a 4 foot high bronze aluminum fence around the property convened at 7:02 pm. The Commission reviewed the application with Jock and Lee Lawrason, who are the new property owners, having just purchased the home from William Lienhard and Launa Schweizer. The application was amended to install natural wood fencing instead of bronze aluminum.

There being no further members of the public present to speak in regard to the application, the public hearing was adjourned at 7:04 pm.

1. The public hearing published April 10, 2026 in the Republican American, Application #2650, Chabad Lubavitch of Litchfield County LLC, 85 West St, to replace 7 windows with impact windows, install fence with gates, install security lights and cameras, and replace 2 doors convened at 7:04 pm. The Commission reviewed the application. The Commission would like to see the security cameras and lights to be positioned high and back from the front to minimize visual impact. Additional clarifications are needed regarding windows and doors. The application will be held over to the next meeting on May 7, 2026, pending applicant's representative attending or participating.

Michael Rybak, Sr who owns the building next to the Applicant expressed his concerns about the condition of the property and the visibility of the proposed location of the fence.

There being no further members of the public present to speak in regard to the application, the public hearing was adjourned at 7:14 pm.

The public hearing published April 10, 2026, in the Republican American, Application #2651, Oliver Wolcott Library, 160 South St, to install a small granite stone plaque to mark the Liberty Tree to be planted convened at 7:14 pm. Add a field stone planter convened at 7:21 pm. The Commission reviewed the application with Julia Metcalf, spouse and Architect, who made slight modifications to dimensions in the original application.

There being no further members of the public present to speak in regard to the application, the public hearing was adjourned at 7:24 pm.

4. The public hearing published April 10, 2026 in the Republican American Application #2653A & B, Jennifer and Frederick Cipoletti, 221 North St, to install a privacy fence with arbor and gate along the property line, install cupola on garage, install trellis on east face of garage, and add gravel and blue stone paving on east side of garage convened at 7:25 pm. The Commission reviewed the application with Julia Metcalf, Architect. Details about the weathervane were provided.

There being no further members of the public present to speak in regard to the application, the public hearing was adjourned at 7:31 pm.

I. Call To Order

II. Recording of Attendance:

III. Business Pertaining To Certificates of Appropriateness.

    2. Application #2654, Michael and Lisa Archibald, 180 South St., to replace existing gravel driveway and semi-circular driveway with gravel pressed into asphalt. The Commission reviewed the application.
    3. Waiver, Paul and Donna Frank, 130 South St., to install A/C and heat pump system behind the house, which is not visible from the public way. The Commission reviewed the application with Paul Frank.
    4. Application #2655, Michael Brady, 148 West St., to replace existing 3-4' high picket fence, with new 6' high solid lattice top fence, cedar material. The Commission reviewed the application with Michael Brady.
