I. Call to order: The meeting was called to order at 6:00 p.m. by G. Carr.

II. Approval of Minutes:

Researching how long after a storm the property owners have to remove the snow from the sidewalks in front of their property.
 - a. Mr. Johnson moved to allow Mr. Vermilyea the authority to notify the snow removal contractor in the event of a violation after the passage of the appropriate amount of time to clear the premises, remove the snow and ice at cost to the landscaper plus 25% to the borough. Ms. Witty seconded. All in Favor.
