The Borough of Litchfield Historic District Commission held **Public Hearings** on **Thursday, October 19, 2023** at the First Congregational Church, Pilgrim House, 21 Torrington Road, Litchfield, Connecticut. The hearings were called to order by Vice Chairman, Wendy Simoncelli, at 7:00pm.

Karen Cowperthwaite, of Cowperthwaite & Co. Landscape Architecture, LLC had notified the Commission that the homeowners are still considering how/if to redesign the driveway to narrow it and requested that this application be held over to the next meeting. The Application has been held over until the next meeting on November 2, 2023, pending homeowners redesign plan.

There being no further members of the public present to speak in regard to the application, the public hearing was adjourned at 7:10pm.

3. The public hearing, published October 13, 2023 in the Republican American, Application #2440, Barry Marcus, 74 North St., for installing a new cedar roof and adding copper gutters, convened at 7:10pm. The Commission reviewed the application.

There being no further members of the public present to speak in regard to the application, the public hearing was adjourned at 7:12pm.

4. The public hearing, published October 13, 2023 in the Republican American, Application #2441, Giancarlo and Jane Keltner, 153 North St., to remove a stockade fence and install a split rail fence, convened at 7:12pm. The Commission reviewed the application.

II. Recording of Attendance

III. <u>Business Pertaining To Certificates of Appropriateness</u>

1. Application #2433, Town of Litchfield, 74 West St, to remove five (5) A/C window units on lower floor west side and install two (2) condensers. Mr. Hillman made a motion to approve the application with discussion. Mr. Ambrose-Sauer seconded. Discussion ensued about the location of the condensers which are visible from the public way and can't be shielded from view, since they are high on the walls and can't be installed on the roof. There is one other similar situation and prior precedent in the borough - on the east wall of Ollie's pizza the condensers were approved for installation in the alleyway. Stipulations for 74 West St. were discussed. Mr. Ambrose-Sauer amended the motion to approve the application with the following stipulations (a) move the western condenser one window bay to the north (towards the back of the building), (b) paint the wall mounting brackets to match the color of the building, and (c) paint the PVC conduit to match the color of the building. Mr. Hillman seconded. Motion carried.

The roll call vote was: Simoncelli – yea, Hillman – yea, Ambrose-Sauer – yea, Cecchinato - yea. The Certificate of Appropriateness is hereby issued for work described in said application as stipulated and is valid for one year from approval.

- Application #2438, Brian and Rina McNamara, 173 South St., for circular driveway with oil and stone and cobble edging, expand bluestone walkway, and install granite post with house number. The Application has been held over until the next meeting on November 2, 2023, pending redesign.
- Application #2440, Barry Marcus, 74 North St., for installing a new cedar roof and adding copper gutters. Mr. Cecchinato made a motion to approve as submitted and seconded by Mr. Ambrose-Sauer. Motion carried.
